# **Organization Description**

Girls on the Run of Northwest Arkansas is a non-profit 501(c)(3) organization whose mission is to educate and prepare young girls for a lifetime of self-respect and healthy living. Much more than a running program, GOTR of NWA is a learning experience which combines training for a 5K event with important life skills lessons designed to encourage positive emotional, social, mental and physical development in 3<sup>rd</sup>-8th grade girls. Since our council's inception in 2004 we have impacted the lives of over 14,000 local NWA girls!

**<u>Position:</u>** Program Director – full time with flexible hours (35)

Purpose: Ensure fidelity of implementation and quality control of the GOTR program

Principle Responsibilities include but are not limited to:

- Oversees program delivery and volunteer coaches
- Provide resources, recognition and support to the coaches
- On-site visits to ensure quality delivery of the program
- Train new coaches and ongoing training for coaches (will receive training to appropriately do so)
- Coordinate and develop site liaisons
- Distribute and follow up with site applications, communicating with coaches/site liaisons
- Pinwheel management set up program registration, coach recruitment and site applications, assign coaches to sites
- Help recruit schools and volunteers
- Create and distribute all correspondence for registration for the sites
- Create and replenish coach bags
- Administrator of GOTR learning academy for online coach training
- Review Coach roster and follow up where needed
- Answer inquiries from interested parents, schools and volunteers
- Coordinate online registration process for the sites
- Send pictures to Marketing Director to Instagram and Facebook
- · Locating snack sponsorships for the team sites

#### Additional Responsibilities -

- Reports to the Executive Director
- Prepare monthly status report for the Board
- Ability to work some evenings and weekends as needed

# **Physical Demands and Work Environment**
